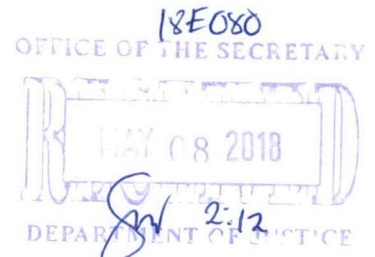

SPECIAL ORDER NO. 402

DESIGNATING DEPUTY EXECUTIVE SECRETARY MICHAEL P. ONG AS ACTING EXECUTIVE SECRETARY DURING THE EXECUTIVE SECRETARY'S VISIT TO THE UNITED STATES OF AMERICA ON 12-26 MAY 2018

WHEREAS, the Executive Secretary will be in the United States of America on 12-26 May 2018;

WHEREAS, to ensure continuity of government service, it is necessary to designate an Acting Executive Secretary to take care of the day-to-day operations in the Office of the President and assist the President in the general administration of the Executive Department;

NOW, THEREFORE, I, SALVADOR C. MEDIALDEA, by the powers vested in me by the law, do hereby designate Deputy Executive Secretary Michael P. Ong as Acting Executive Secretary from 12 May 2018 to 26 May 2018.

All departments, agencies, and instrumentalities of the Government shall assist the Acting Executive Secretary in the discharge of his functions as stated herein.
