RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO SHERATON MANILA BAY FOR THE PURCHASE OF PACKED MEALS FOR THE IACAT TIP CENTER INAUGURATION ON 16 DECEMBER 2020

WHEREAS, there is a need for the purchase of packed meals for the IACAT TIP Center Inauguration on 16 December 2020;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan;

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P72,000.00;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days and was sent to three (3) prospective suppliers, namely: Sheraton Manila Bay, The Manila Hotel and Jen Manila;

WHEREAS, in response to the said invitation, three (3) prospective suppliers submitted their quotations, to wit,

WHEREAS, after review and evaluation, BAC-TWG, found Sheraton Manila Bay to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **SEVENTY TWO THOUSAND PESOS (P72,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **SHERATON MANILA BAY** for the purchase of packed meals for the IACAT TIP Center Inauguration on 16 December 2020 in the amount of **SEVENTY TWO THOUSAND PESOS (P72,000.00)**.


