RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO EMMARS AIRCONDITIONING SERVICES FOR THE GENERAL CLEANING OF AIR-CONDITIONING UNITS

WHEREAS, there is a need for a general cleaning of the air-conditioning units in the Department of Justice (DOJ);

WHEREAS, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP) with an allotted budget of Four Hundred Thousand Pesos (₱ 400,000.00);

WHEREAS, the Invitation to Bid for the aforementioned project with an Approved Budget for the Contract of Three Hundred Fifty-Five Thousand One Hundred Sixteen Pesos & 67/100 (₱ 355,116.67) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the DOJ starting 9 June 2021;

WHEREAS, in the pre-bidding conference held on 16 June 2021, the following prospective bidders participated, namely, Emmars Airconditioning Services, Rose Aire Enterprises, Inc., Epsco Philippines, and Sundra Airconditioning Services;

WHEREAS, during the bidding conference held on 29 June 2021 at 10:00 am, *via google meet*, the following bids were submitted, to wit:

WHEREAS, the said bids were referred to the BAC-Technical Working Group (TWG) for evaluation and post-qualification, and noted the following findings:

No. 9184 and its 2016 Revised Implementing Rules and Regulations.
