RESOLUTION

A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO STRATEGIC SUPPLIES AND SAFETY GEARS TRADING FOR THE PURCHASE AND PRINTING OF ADVOCACY IACAT T-SHIRTS IN CELEBRATION OF THE WORLD DAY AGAINST TRAFFICKING BLUE HEART CAMPAIGN 2021, TO BE DISTRIBUTED TO MEMBERS OF THE REGIONAL ANTI-TRAFFICKING TASK FORCE VI AND RIACAT PARTNER AGENCIES

WHEREAS, there is a need for the purchase and printing of Shirts in celebration of the World Day Against Trafficking Blue Heart Campaign 2021 on July 30, 2021;

WHEREAS, the procurement for the purchase and printing of Advocacy Shirts for the said event is included in the approved FY 2021 Annual Procurement Plan (APP) with allotted budget of Twenty Five Thousand Pesos (**P 25,000.00**);

WHEREAS, the conduct of said event is designed to strengthen the campaign Against Human Trafficking and to celebrate the World Day Against Trafficking Blue Heart Campaign 2021.

WHEREAS, pursuant to the procedures for the procurement of Shirts, the department requested three (3) suppliers to submit quotations, namely: **Bid-D Shirt Tailoring; T-Shirt Printing Services, Iloilo; and Strategic Supplies and Safety Gears Trading** to wit:

WHEREAS, among the three (3) suppliers that submitted its quotations, **Strategic Supplies and Safety Gears Trading** provided the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Department of Justice, Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **Strategic Supplies and Safety Gears Trading**, for supplying and printing of advocacy shirts in celebration of the World Day Against Trafficking Blue Heart Campaign 2021, which will be distributed to members of the IACAT Regional Anti-Trafficking Task Force 6 and the Regional Inter-Agency Committee Against Trafficking on July 30, 2021 in the amount of **Twenty-Four Thousand, Seven Hundred Fifty Pesos** following the procedures prescribed by R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
