RESOLUTION NO. 2021-08-0007

BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO APRIL JOY HOME DECORS AND FURNITURE FOR THE PURCHASE OF CONFERENCE TABLE, 10 SEATERS FOR NPS- REGION 1

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), requested quotations for the purchase of conference table, 10 seaters with the Approved Budget for the Contract (ABC) of Thirty Thousand (Php30,000.00);

WHEREAS, the BAC received three (3) quotations for the purchase of the 10-seater conference table from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, as a result of bid opening, ELYU Supply Enterprise OPC was declared the 1st Lowest Calculated and Responsive Bid;

WHEREAS, April Joy Home Decors and Furniture was declared the 2nd Lowest Calculated and Responsive Bid;

WHEREAS, MSN Consumer Goods Trading was declared the 3rd Lowest Calculated and Responsive Bid and no provided specifications;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the bidders, the BAC found all of them to be eligible and responsive. Nonetheless, the BAC considered the dimensions **(320 cm x 120 cm x 75 cm)** and quality offered by the suppliers and BAC found the bid of April Joy Home Decors and Furniture, the 2nd Lowest Calculated and Responsive Bid (LCRB), to be more favorable and beneficial to the government/end-user with a price difference of Php1,000.00 from the 1st LCRB (280 cm. x 120 cm x 75 cm).

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity the award and approval of Purchase Order No. 2021- 08- 007 in the amount of Twenty-Two Thousand Five Hundred Pesos (Php 22,500.00) for the purchase of Conference Table, 10 seaters for NPS- Region 1 in favor of **April Joy Home Decors and Furniture**.
