RESOLUTION NO. 2021-08-0010

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
EAGLENORTH MEDICAL TRADING FOR THE PURCHASE OF COVID-19
RELATED SUPPLIES FOR NPS- REGION 1**

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the notice to purchase Covid-19 related supplies with the Approved Budget for the Contract (ABC) of One Hundred Ninety Two Thousand, Four Hundred Fifty Four Pesos and 80/100 (Php 192,454.80) from August 16-20, 2021 in the PhilGEPS, DOJ website and in a conspicuous place in the premises of the City of San Fernando, La Union;

WHEREAS, the BAC received five (5) quotations for the purchase of Covid-19 related supplies from five (5) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the LCRB, the BAC found the offer of Eaglenorth Medical Trading to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for the award of the contract;
