RESOLUTION

RECOMMENDING THE APPROVAL OF THE AGENCY-TO-AGENCY AGREEMENT BETWEEN THE DEPARTMENT OF JUSTICE AND THE CIVIL SERVICE COMMISSION FOR THE CONDUCT OF THE COMPETENCY-BASED HUMAN RESOURCE COURSES AND COACHING SESSIONS

WHEREAS, there is a need to conduct the implementation of the Competency-Based Human Resources and Coaching Sessions for the Department of Justice (DOJ) officials and employees;

WHEREAS, the conduct of the said project is included in the approved CY 2021 Annual Procurement Plan (APP) with a total allotted budget of Seven Hundred Eighty Thousand Pesos (P780,000.00);

WHEREAS, in a Memorandum dated 19 April 2021, the Training Section requested for the issuance of BAC Resolution for Agency-to-Agency Procurement relative to the conduct of the Competency-Based Human Resource Courses and Coaching Sessions for the Department;

WHEREAS, in its Memorandum, Director Liza B. De Leon, of the Administrative Division proposed to enter into a Memorandum of Agreement (MOA) with the Civil Service Commission – Civil Service Institute (CSC-CSI) for the implementation of the said Competency-Based Human Resource Courses and Coaching Sessions, which will be held on 3 August to 25 November 2021, which is more efficient and economical to the government;

WHEREAS, the training fee of CSC-CSI for the delivery of the said program is in the amount of Five Hundred Twenty Thousand Pesos (P520,000.00);


WHEREAS, the said engagement by the Department of CSC-CSI for the implementation of the program falls within the Negotiated Procurement of *Agency-to-Agency*, an alternative mode of procurement allowed under Section 53.5 of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, which provides :

53.5. **Agency-to-Agency.** Procurement of Goods, Infrastructure Projects and Consulting Services from another agency agency of the GoP, such as DBM-PS, which is tasked with a centralized procurement of Common-Use Supplies for the GoP in accordance with Letter of Instructions No. 755 and E.O. 359, s. 1989.

NOW, THEREFORE, for and in consideration of the foregoing premises, the Bids and Awards Committee **RESOLVES**, as it hereby **RESOLVE**, to **RECOMMEND** the use of Agency-to-Agency Agreement with the Civil Service Commission – Civil Service Institute for the Conduct of the Competency-Based Human Resource Courses and Coaching Sessions for DOJ officials and employees, in the amount of Five Hundred Twenty Thousand Pesos (P520,000.00) following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


