RESOLUTION NO. 2021-09-0011

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MSN
CONSUMER GOODS TRADING FOR THE PURCHASE OF VARIOUS OFFICE
SUPPLIES FOR NPS- REGION 1**

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the purchase of various office supplies with the Approved Budget for the Contract (ABC) of One Hundred Eighty Two Thousand, Five Hundred Sixty Pesos and 85/100 (Php 182,560.85) on September 20-24, 2021 in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union;

WHEREAS, the BAC received three (3) quotations for the purchase of various office supplies from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:

WHEREAS, as a result of bid opening, MSN Consumer Goods Trading's bid was declared the 1st Lowest Calculated and Responsive Bid (LCRB);


WHEREAS, ELYU Supply Enterprise OPC's offer was declared the 2nd LCRB while New Malayan Commercial was non-responsive;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the Lowest Calculated Bidder, the BAC found the offer of MSN Consumer Goods Trading to be compliant. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for award of contract;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby **RESOLVED** to the Head of the Procuring Entity to recommend the award and approval of the Purchase Order No. 2021- 09- 011 in the amount of One Hundred Seventy Two Thousand, Six Hundred Seventy Six Pesos and 30/100 (Php 172,676.30) for the purchase of Various Office Supplies for NPS- Region 1 in favor of MSN Consumer Goods Trading.


