## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT FOR THE RENEWAL OF MANAGED SECURITY INFORMATION AND EVENT MANAGEMENT TO ePLDT, INC.**

**WHEREAS**, there is a need to procure the renewal of the Managed Security Information and Event Management (SIEM) for the Information and Communications Technology Service (ICTS) of the Department of Justice (DOJ);

**WHEREAS**, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP) with an Approved Budget for the Contract of Three Million Pesos (₱ 3,000,000.00);

**WHEREAS**, the Invitation to Bid (ITB) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the DOJ starting 30 July 2021;

**WHEREAS**, in the pre-bidding conference held on 9 August 2021, the following prospective bidders participated, namely, I-Connect Systems Integration, Inc., ePLDT, Inc., NXTGEN, and Integrated Computer Systems;

**WHEREAS**, only one bidder, ePLDT, Inc., bought bid documents and submitted its bid with the corresponding amount stated below and was subjected to bid evaluation on 23 August 2021 at 11:00 am, *via google meet*, *to wit*:

**WHEREAS**, the said bid was referred to the BAC-Technical Working Group (TWG) for evaluation and post-qualification, and noted the following findings:

**WHEREAS**, after review and evaluation, the BAC-TWG finds ePLDT, Inc. to have submitted the single, calculated, and responsive bid and is legally, financially, and technically capable to undertake the project;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract for the renewal of the Managed Security Information and Event Management to **ePLDT, INC.** in the amount of **TWO MILLION PESOS (P 2,000,000.00)**, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


