**RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO THE BRAIN  
COMPUTER CORPORATION FOR THE SUPPLY, DELIVERY AND

**WHEREAS**, the Request for Quotation (RFQ) for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days;
