RESOLUTION NO. 2021-08-0008

BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ELYU SUPPLY ENTERPRISE OPC FOR THE PURCHASE OF STEEL INDEX CARD FILE CABINET, 12 DRAWERS OR MORE FOR NPS- REGION 1

WHEREAS, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), posted the notice to purchase of steel index card file cabinet, 12 drawers or more with the Approved Budget for the Contract (ABC) of One Hundred Ninety Thousand Pesos (Php 190,000.00) from August 2-6, 2021 in the PhilGEPS, DOJ website and in conspicuous place in the premises of the City of San Fernando, La Union;

WHEREAS, the BAC received three (3) quotations for the purchase of the steel index card file cabinet with 12 drawers or more, from three (3) suppliers. Hereunder are the names of suppliers with their respective bids:


