RESOLUTION DECLARING FIRST FAILURE OF BIDDING AND RECOMMENDING RE-BIDDING FOR THE OFFICE REPAIR, RENOVATION AND MAINTENANCE OF CITY PROSECUTION OFFICE OF NAGA INCLUDING LABOR AND MATERIALS.

WHEREAS, the Department approved the budget of Two Hundred Seventy-Five Thousand Pesos Only (P 275,000.00) for the Office Repair, Renovation and Maintenance of City Prosecution Office of Naga including Labor and Materials;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the submission and opening of bids was scheduled on 07 October 2021;


WHEREAS, only one bidder from Rei-Tech Construction and Supply submitted its bid for the said procurement project;


WHEREAS, during the Bid Opening, the BAC has found Rei-Tech Construction and Supply, INELIGIBLE, due to its bid offer is above the Approved Budget for the Contract (ABC);

WHEREAS, that on the basis of the quotation given and after judicious evaluation, no supplier was able to meet the specifications and eligibility requirements;




