RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF OFFICE REPAIR, RENOVATION AND MAINTENANCE OF OPP SORSOGON INCLUDING LABOR AND MATERIALS: REPLACEMENT OF FOUR (4) TOILET FLUSH DOORS AND FOUR (4) DOOR KNOBS; REPLACEMENT OF 100 PIECES 20 WATTS NX LED FLUORESCENT LIGHTS; WATER PROOFING (FIREWALL WAST); INSTALLATION OF BUILT-IN SHELVES IN THE FOLLOWING AREAS: CONFERENCE AREA; LIBRARY AND RECORD ROOM THROUGH NEGOTIATED PROCUREMENT SMALL VALUE PROCUREMENT SECTION 53.9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of Four Hundred Ninety-Eight Thousand Pesos (P498,000.00) for the Procurement of Office Repair, Renovation and Maintenance of OPP Sorsogon including labor and materials: replacement of four (4) toilet flush doors and four (4) door knobs; replacement of 100 pieces 20 watts NX LED Fluorescent lights; water proofing (firewall wast); installation of built-in shelves in the following areas: conference area, library and record room;

WHEREAS, the Regional Prosecution Office V through the Bids and Awards Committee (BAC), posted the Request for Quotation (RFQ) for the above-mentioned project in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and in conspicuous place in the premises of Regional Prosecution Office V;

WHEREAS, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers;

1. Chanbro Civil Engineering Services
2. Rei-Tech Construction and Supply
3. Steven Construction and Supply
4. ROEM Enterprise and Construction Services

WHEREAS, the submission and opening of bids was scheduled on July 19, 2021;

WHEREAS, on various dates prior to the opening of bid documents, quotations from three (3) suppliers were obtained by the BAC Secretariat, attested by accomplished Request for Quotation (RFQ);

WHEREAS, in the course of the evaluation of the bids by the BAC the following are the result:

Supplier	Bid Amount	Remarks
a. LJDB Construction	Php490,000.00	ELIGIBLE, complete requirements
b. Chanbro Civil Engineering Services	Php483,000.00	INELIGIBLE, non-compliant with eligibility requirements specifically, no Certificate of PhilGEPS Registration and the attached documents such as Mayor's permit, DTI Registration, PCAB License were not certified true copy.
c. Rei-Tech Construction and Supply	Php497,000.00	Ineligible, highest bidder


WHEREAS, per evaluation, the proposal of LJDB Construction is found to be compliant with the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.



1. AWARD OF CONTRACT via Small Value Procurement to LJDB Construction for the Procurement of Office Repair, Renovation and Maintenance of OPP Sorsogon including labor and materials: replacement of four (4) toilet flush doors and four (4) door knobs; replacement of 100 pieces 20 watts NX LED Fluorescent lights; water proofing (firewall wast); installation of built-in shelves in the following areas: conference area, library and record room in the amount of Four Hundred Ninety Thousand Pesos (Php490,000.00) inclusive of appropriate taxes and fees;




