

CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT ("Contract") is made and entered into this DEC 10 2021 at CITY OF MANILA Philippines, by and between:

The **DEPARTMENT OF JUSTICE (DOJ)**, a national government agency, with office address at DOJ Compound, Padre Faura Street, Ermita, Manila, herein represented by its Undersecretary **ADRIAN FERDINAND S. SUGAY**, and hereinafter referred to as the "**PROCURING ENTITY**".

In consideration of the payments to be made by the **PROCURING ENTITY** to the **SERVICE PROVIDER** as hereinafter mentioned, the **SERVICE PROVIDER** hereby covenants with the **PROCURING ENTITY** to provide the services and the remedy defects therein in conformity in all respects with the provisions of the **Contract**.
 5. The **PROCURING ENTITY** hereby covenants to pay the **SERVICE PROVIDER** in consideration of the provision of the services and the
