

CONSULTANCY CONTRACT

This **CONTRACT** made and entered into this 3rd day of January 2022 in the City of Manila by and between:

The **WITNESS PROTECTION, SECURITY AND BENEFIT PROGRAM (WPSBP)**, an Office created under Republic Act No. 6981, herein represented by its Program Director **SDSP THEODORE M. VILLANUEVA**, Department of Justice, Padre Faura, Manila, hereinafter referred to as the "Program";

-and-

FLERIDA A. JIMENEZ, of legal age, married and with residence and postal address at 20 J.M. Basa Compound, E. Rodriguez, Jr. Avenue, Quezon City, hereinafter referred to as **CONSULTANT**;

WITNESSETH, that:

1. Pursuant to the provisions of R.A. No. 6981, Witness Protection Security and Benefit (WPSP) Act, and CSC-COA-DBM Joint Circular No. 1 dated June 15, 2017, the WPSBP hereby employs the **CONSULTANT** to provide policy determining, primarily confidential and highly technical services to the WPSBP; including advice and assistance on the following:
 - a. Grant and utilization of fund authorized for the implementation of the WPSBP;
 - b. Streamline disbursement operations and institute control mechanism for check and balance;
 - c. Documentation of Confidential cash advances and liquidation thereof;
 - d. Extend technical assistance on problems that arise on the use of the WPSBP Confidential Funds; and,
 - e. Other services and functions as maybe directed by the Secretary of Justice and the WPSBP Program Director;
2. The Program has available fund for this purpose;
3. The Program agrees to pay the **CONSULTANT** a regular monthly consultancy fee in the sum of **FIFTY SIX THOUSAND PESOS (P56,000.00)**, effective **January 3, 2022 up to June 30, 2022**, to be paid on a monthly basis.
4. Pursuant to the provision of R.A. No. 9184, this Contract shall be for a maximum period of six (6) months, renewable at the option of the Head of Procurement Entity (HOPE), but in no case shall exceed the term of the latter;

5. All confidential matters/information obtained during the consultant's employment with the WPP shall be kept by her in confidence even after the termination of the contract and shall not be divulged to any person other than the authorized Program Implementor/s. Violation of this clause shall be subject to the penal provision of Section 7 paragraph 2 of R.A. No. 6981 and such action as the WPP may deem proper to take;
6. Should the WPSBP be dissolved/discontinued for any reason, this Contract shall be ipso facto terminated and the WPSBP shall not be liable for the pre-termination of this Contract; and
7. The **CONSULTANT** hereby accepts this consultancy contract and conditions herein prescribed.
