RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC) FOR THE CONDUCT OF THE 47TH COUNCIL MEETING OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING (IACAT) TO BE HELD ON 4 JULY 2019

WHEREAS, there is a need for a venue for the conduct of the 47th Council Meeting of the Inter-Agency Council Against Trafficking (IACAT) to be held on 4 July 2019;

WHEREAS, the procurement for the lease of venue for the said event is included in the approved FY 2019 Annual Procurement Plan (APP) with an allotted budget of **Two Hundred Forty-Eight Thousand Pesos (P248,000.00)**;

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;


WHEREAS, the Philippine International Convention Center (PICC) is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **PICC**, for the conduct of the **47th Council Meeting of the Inter-Agency Council Against Trafficking (IACAT)** to be held on 4 July 2019, in the amount of **Eighty-Eight Thousand Pesos (P88,000.00)**, following the procedures prescribed by R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
