## **RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO PHILIPPINE INTERNATIONAL CONVENTION CENTER FOR THE CONDUCT OF PREPARATORY ACTIVITY FOR THE GLOBAL REFUGEE FORUM OF THE REFUGEES AND STATELESS PERSONS PROTECTION UNIT OF THE DEPARTMENT OF JUSTICE WITH THE UNITED NATIONS HIGH COMMISSIONER FOR REFUGEES AND OTHER GOVERNMENT AGENCIES TO BE HELD ON 29-30 OCTOBER 2019**

**WHEREAS**, there is a need for a venue for the conduct of Preparatory Activity for the Global Refugee Forum of the Refugees and Stateless Persons Protection Unit (RSPPU) of the Department of Justice (DOJ) with the United Nations High Commissioner for Refugees (UNHCR) and other government agencies to be held on 29-30 October 2019;

**WHEREAS**, the procurement for the lease of venue for the said event is included in the CY 2019 Supplemental Annual Procurement Plan No. 3 (SAPP 3) with an allotted budget of Two Hundred Eighty Thousand Pesos (P280,000.00);

**WHEREAS**, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned<sup>1</sup>;

**WHEREAS**, the Philippine International Convention Center (PICC) is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;

**WHEREAS**, based on the aggregate charges sheet submitted by PICC, the total cost of lease of venue for the said activity, including the use of meeting room and meals, is Two Hundred Seventy-Three Thousand Pesos (P273,000.00);

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to the **PICC**, for the conduct of the Preparatory Activity for the Global Refugee Forum of RSPPU of DOJ with UNHCR and other government agencies to be held on 29-30 October 2019 in the amount of Two Hundred Seventy Three Thousand Pesos (P273,000.00), following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
